#### BINDING ARBITRATION

#### MEDIATION AND ARBITRATION

In respect to any controversy or claim that may arise out of or relate to this CONTRACT in any manner, including but not limited to a breach of this CONTRACT, the parties initially shall submit

such controversy or claim to mediation conducted in accordance with the Commercial Mediation

Rules of the American Arbitration Association. Any controversy or claim not resolved following

mediation conducted in conformity with this Section shall be settled by arbitration according to the

Commercial Arbitration Rules of the American Arbitration Association. Following entry of an award

by the Arbitrator, a party seeking to enforce the award may have the judgment entered in any

having jurisdiction over the other party. If YOU intend to exercise your right to seek arbitration, YOU

must give us notice of YOUR intent to seek arbitration by delivering a written statement of the

controversy or claim to US at: 6701 Antire Rd., High Ridge, MO. 63049

We require a \$1,000 tuition deposit along with signed copies of our enrollment agreement to secure your spot in class. This \$1,000 is deducted from your tuition and is subject to the Initial. Here, following: You may cancel your enrollment agreement with a refund of all money paid for a period of no more than three days of the date of your signed agreements, exclusive of weekends

and nationally observed holidays. After this initial three-day period, the tuition deposit of \$1,000 is non-refundable. If mitigating circumstances prevent attendance of the selected date of enrollment, we postpone attendance until the next available starting date. We will only move your deposit one time.

The first week begins on the first day of class and is week number one. Each consecutive week of the program begins at 12:01 a.m. Sunday morning, regardless of the attendance of an individual student. (For instance, if a student misses the entire third week and returns the following week, it is still counted as week number four). Depending on when holidays fall, classes may be cancelled for more than one day. This is to allow those students who wish to go home for the holidays the opportunity to do so. All training facilities will be open and available to students who do not wish to leave for the holidays.

To withdraw, you must submit a written withdrawal form to the admissions officer. Any applicable refund of tuition is computed as of the date the withdrawal form was received and signed by admissions. For those students utilizing VA benefits, a refund will be computed by the VA and refunded accordingly.

All outstanding balances owed by the student (such as rent, utilities, damages, merchandise) are deducted from the refund.

#### REFUND POLICY

The Tom Rose School, LLC deducts the following percentages at the beginning of each week:

- Professional Pet Trainer Program (8 weeks): \$10,000 Tuition
  - o TRS deducts 25% of tuition at the beginning of each week of class (weeks begin on Sunday morning 12:01 AM). We no longer give a refund after the start of the 4th week of the course, regardless of student attendance. Student withdrawal must be in writing and is recorded on the date of receipt.
- Master Dog Trainer Program (20 weeks): \$18,000 Tuition
  - We deduct 25% of tuition at the beginning of each week of class (weeks begin on Sunday morning 12:01 AM). We no longer give a refund after the start of the 4<sup>th</sup> week of the course.

## **Refund Policy for Veterans or Eligible Persons**

A refund of the unused portion of tuition will be made to The Department of Veterans Affairs if the veteran student fails to complete the course as required by The Department of Veterans Affairs Regulations, CFR 21.4255. The refund will be an exact prorate refund. This refund policy applies in cases listed as "without refund". The Tom Rose School, LLC complies with the Veterans and Transactions Act of 2013. See footnote at the end of our Catalog.
